NOTICE OF NOMINATION MEETING AND ELECTION

Please be advised that nominations for a three (3) year term of office, effective January 1, 2023 through December 31, 2025 for the Offices of President, Secretary-Treasurer, Vice-President, Recording Secretary and three (3) Trustees, shall be conducted as follows:

The Nomination Meeting shall be conducted on Thursday October 27, 2022, at 6:00 P.M. at Lake Ridge Pointe Office Center located at 1000 Burr Ridge Parkway, Burr Ridge, Illinois.

Every member, whose union dues are paid through the month of September 2022, shall have the right to nominate a Candidate.

Article II, Section 4(a) of the International Constitution requires that to be eligible for election to any office in a Local Union, a member must be in continuous good standing in the Local Union in which he/she is a member and in which he/she is seeking office, and actively employed at the craft within the jurisdiction of such Local Union, for a period of twenty-four (24) consecutive months prior to the month of nomination for said office and must be eligible to hold the office if elected. "Continuous Good Standing" means compliance with the provisions of Article X, Section 5 of the International Brotherhood of Teamsters Constitution concerning the payment of dues for a period of twenty-four (24) consecutive months, together with no interruptions in active membership in the Local Union for which office is sought because of suspensions, expulsions, withdrawals, transfers or failure to pay monthly union dues obligation, fines or assessments.

Nominations of Candidates are to be made orally from the floor of the Nomination Meeting by motion of any member in good standing other than the Nominee and seconded by one other member in good standing other than the Nominee.

Prospective Nominees are advised to verify, in advance of the Nomination Meeting, the eligibility of themselves, their Nominators and Seconders with the Office of the Secretary-Treasurer.

The election shall be conducted by mail ballot. Ballots shall be mailed to members on November 4, 2022. Ballots shall be counted on November 28, 2022, at 1000 Burr Ridge Parkway, Burr Ridge, Illinois at 9:00 A.M. or as soon thereafter as ballots are retrieved from the designated post office box.

Nomination and Election Rules shall be in accordance with the By-Laws of Teamsters Local Union No. 731, the Constitution of the International Brotherhood of Teamsters and in accordance with Teamsters Local 731 Executive Board Rules. Nomination and Election Rules are available upon request made to the Secretary-Treasurer at the Office of the Union, 1000 Burr Ridge Parkway, Suite 300, Burr Ridge, Illinois 60527. All Candidates, Nominators and Seconders are encouraged to review the Nomination and Election Rules.

The Officers elected by virtue of the forthcoming election shall serve as Delegates to all Teamsters' subordinate bodies and all other conventions, except the International Convention as provided in the International Brotherhood of Teamsters Constitution.
